#### 4 ELIGIBILITY REQUIREMENTS:

For M.E./M.Tech. (CEEP) programmes – 6 Semesters (3 years) in CIVIL, CSE, ECE, EE, MECH. and Mining Engineering

##### 1. Eligibility Criteria:

###### 4.1 Educational Qualification:

- a) B.E./B.Tech of any Recognized University in the concerned discipline, or its equivalent.
- b) AMIE/AMIETE or similar qualifications recognized by AICTE, New Delhi as equivalent to B.E./B.Tech.
- c) Minimum % of Marks in Qualifying Exams - 50% for OC/BC/OBC and 45% for SC/ST.
- d) The candidates having higher aggregate percentage of marks obtained in the qualifying examination will be considered for admission.

**4.2 Experience:** The Admission for sponsored category is only for the employees who have put in *One year of Service as on 31-08-2024* working in Industry / Education / Research establishment / Proprietary Concern and should be sponsored by respective employers.

**4.3** The candidate have to produce sponsorship letter and No-objection certificate (Proforma - A) from the employer at the time of counseling. The sponsorship certificate is subject to verification and if the information provided is found to be False, the admission will be cancelled at any point of time and legal action will be initiated.

**4.4** The Place of employment shall be within 100 km radius from OU, Hyderabad.

5. All the applicants are required to download the Application form and letter of Sponsorship/Nomination (Proforma "A") from the website [www.uceou.edu](http://www.uceou.edu). All entries in the application form should be filled in by the candidate.
6. A Separate application should be submitted for each Department in which the admission is sought.

  - vii) Caste certificate in case of SC/ST/BC

The fee for each semester Rs.45,000/- (Tuition Fee) + Rs.9,500/- (One time autonomous fee at the time of admission) and the counseling fee of Rs.1,000/- to be paid in cash.
